Current Draft of Standing Committees in HCNCS Bylaws as of 11/5/25

Standing Committees

Standing Committees shall advise and assist the Commission in carrying out its duties and responsibilities. Committee chairs shall be appointed by the Commission Chair from among Commission members [with the exception of the Finance [Committee] and Bylaws and Nominations e[C]ommittee[s] which shall be elected annually by the membership of the Commission for a term of one year]. The Commission Chair, in consultation with the Committee Chairs, shall name the committees' members. Standing Committees the Commission shall include, but may not be limited to the following.

Section 1. Executive Committee

- 1.01 The Executive Committee shall serve as the strategic planning committee responsible for planning and establishing the agenda for commission meetings and for developing recommendations to the commission on issues that require preliminary reviews when so designated by the full commission.
- 1.02 The Executive Committee shall consist of [the following: the] Chair[,] Vice-Chair[,] [and Secretary] of the Commission, [as well as] the Chairs of the Finance [Committee] and [the] Bylaws [and Nominations] Committee[s], and other interested parties appointed by the Chair.

Section 2. <u>Bylaws [and Nominations] Committee</u>

- 2.01 The Bylaws [and Nominations] Committee shall solicit, review, and recommend nominations for vacant commission positions and to establish and recommend changes to the bylaws of the Hawai'i State Commission for National and Community Service.
- 2.02 The Bylaws [and Nominations] [Committee] shall consist of members of the Commission[.] [The Commission Chair in consultation with the Committee Chair may request participation of subject matter experts as needed.]
- 2.03 The Nominations and Bylaws Committee shall present [at least ten calendar days] prior to the annual meeting a slate of nominees which shall include recommendations for officers for the Commission.]

Section 3. Finance Committee

- 3.01 The Finance Committee shall assist in preparing the State Commission's budget requests on a timely basis, and to monitor expenditures on behalf of the Commission.
 - 3.01.1 [The Commission Chair in consultation with the Committee Chair may request participation of subject matter experts as needed.]

Section 4. Review and Selection Committee

- 4.01 The Review and Selection Committee shall provide a process with which to organize panelists; receive, process, review and assess all grant application proposals; and to submit its recommendations to the full commission utilizing guidelines provided by the Corporation and staff support from the Commission Office, which is housed under the President's office.]
- 4.02 The Review and Selection Committee shall consist of members of the Commission[.] [The Commission Chair in consultation with the Committee Chair may request participation of subject matter experts as needed.] [

Section 5. Evaluation Committee

- 5.01 The Evaluation Committee shall assist staff of the Commission Office, which is housed under the President's office,] in monitoring and assessing programs contracted by the State Commission for National and Community Service; and to determine the quality of the contracted service, compliance with grant and contract requirements, and any follow-up action needed.
- 5.03 The Evaluation Committee shall consist of members of the Commission[.] [The Commission Chair in consultation with the Committee Chair may request participation of subject matter experts as needed.]

Section 6. Youth Voice Committee

- 6.01 The Youth Voice Committee shall develop and recommend policies and programs to the Commission as 1.well as bringing the perspective of young people to all Commission discussions and decisions.
- 6.02 The Youth Voice Committee shall have four to six Commission members who may establish several subcommittees consisting of individuals between the ages of 16 to 25 to determine youth concerns of the State.

Section7. Media Promotion Committee

7.01 The Media Promotion Committee shall promote community awareness about the Commission and programs funded under the Corporation for National and Community Service; and to promote and encourage communication and information sharing between state and local private and public initiatives to meet community needs. [This committee is referenced in Executive Order 94- 01 as the Community Collaboration Committee]

7.02 The Media Promotion Committee shall consist of members of the Commission[.] [The Commission Chair in consultation with the Committee Chair may request participation of subject matter experts as needed.]

Section 8. Program [and Community Collaboration] Committee

- 8.01 The Program [and Community Collaboration] Committee shall promote communication and information sharing between state and local private and public initiatives to meet community needs; and to develop, promote, and · conduct activities that help carry out the goals and objectives of the National and Community Service programs and commission activities.
- 8.02 The Program [and Community Collaboration] Committee shall consist of members of the Commission and other interested parties appointed by the Chair.
